Report on the Implementation of IQAC Suggestions and Actions (Academic season 2022-23)

The IQAC plays an important role in ensuring and enhancing the quality of education and the overall functioning of an institution. Below are the initiatives undertaken by the IQAC throughout the year aimed at improving the quality of the college environment.

- I. The IQAC in anticipation of the 2022-23 session, the IQAC emphasized the necessity of crafting a fresh academic calendar and curricular plan. Academic Committee of the college with the responsibility of drafting and promptly uploading both documents onto the official website, done it on time.
