**Bankura Zilla Saradamani Mahila Mahavidyapith & Gobinda Prasad Mahavidyalaya** recognizing the value of cooperation, have agreed to enter into this Memorandum of Understanding (MoU) regarding academic collaboration. The purpose of this non-binding MoU is to make possible and institute academic and cultural exchange between

**Bankura Zilla Saradamani Mahila Mahavidyapith & Gobinda Prasad Mahavidyalaya** based upon the principles of mutual equality and the reciprocity of benefits. NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH and it is agreed by and between both the colleges hereto as follows:

## 1. PURPOSE

This Memorandum of Understanding (MoU) serves as a written understand of agreed upon Principals between **Bankura Zilla Saradamani Mahila Mahavidyapith** and **Gobinda Prasad Mahavidyalaya** concerning a set of general academic objectives. This is a non-binding agreement and is intended to clarify the nature and extent of the harmonizing activities that might be undertaken for the mutual benefit of the two institutions. Each institution will be responsible for managing its own expenses also share as and when necessary. Commitments of specific institutional resources, personal, space, facilities, or any other academic or intellectual activities considered hereunder may or may not beyond the scope of this MoU. To the extent that the implementation of any agreed upon activity requires a commitment of resources, personal, credit-bearing course work, or intellectual property, a supplementary agreement will be negotiated and approved by the two parties before work on any of the projects can commence.

## 2. Objectives, Scope and Major Activities

- Both institutions agree to encourage the development of the following types of activities.
- Visits and formal exchange of faculty, scholars and administrator in specific areas of education, research and outreach.
- Cooperate in undergraduate education and training through library as well as laboratory resources.
- Organize joint conferences, symposia or other meeting on subjects of mutual interest.
- Exchange of academic information and materials.
- Pursue avenues for undergraduate student exchange during the academic year or through summer / winter internship programs.
- Other exchange and cooperation programs such as extension activities to which both institutions agree.

- Students of both the institutions will have access to the quality enhancement programmes organized by both the institutions.
- Students and faculties of both institutions will collaborate on research initiatives, students' internship programs, and joint research activities and collaborations.
- Explore possibilities towards jointly organising training, certificate courses, Add-on-Courses, outreach programmes, and capacity building, Skill enhancement Programmes programs for both students, faculty members and non-teaching staff.

### 3. Responsibilities of the Institutions

The two institutions identify that the execution of any agreed upon activity will depend upon the interests and expertise of the individuals involved and the availability of financial resources, space and other resources. Accordingly, the functioning of any exchange and cooperative programs based on this MoU shall be conferred and determined between the two institutions. It is further expected that both the institutions will be compliant with all applicable legislations of Government of India and State and University policies.

### 4. STAFF AND STUDENT EXCHANGE PROGRAMME:

- Each party will accept visiting faculty members and students from the other party. The host party will arrange and bear all expenses for board and lodge for the visiting party. All other expenses, including the travel expenses, shall be the responsibility of the visiting party. Each party will strive at organising above programmes through blended mode also.
- That the exchange shall be in a manner of a maximum of six students and two teachers in a given semester. In case of online mode, the number may be increased up to 100.
- That each party will take necessary permissions and/or approval from concerned and competent authorities on matters of staff and student exchange, and all issues arising thereof.

- d. That the selection of students and teachers for such exchange programmes shall be the responsibility of the Principal of the concerned college, and that the host college shall accept only the list duly signed, sealed and communicated by the Principal of the visiting institution to the Principal of the host institution.

## 5. ACTIVITY EXCHANGE PROGRAMME:

- a. That the activity exchange programme shall include exchanges in terms of games and sports, cultural exchange, and the exchange of research materials, publications, and information to facilitate academic and cultural interchange between the parties of the MoU.
- b. The number of faculty and staff members under the activities exchange programme shall be as per the requirement of the activity, and shall be decided and settled prior to the programme between the signatories of this agreement.

## 6. Tenure and Option to Amend, Extend or Terminate

This MoU will become effective when signed by authorities of both institutions. The agreement will remain in effect for five years from the date of signature given below, and may be renewed or amended by mutual agreement of the institutions. The institutions should agree to periodically review the activities undertaken and the progress made and to consult concerning amendments, renewal or termination of this MoU. Either authority may terminate this MoU at any time by providing written notice prior to three months before such termination to the other authority.

## 7. General Terms

This MoU is not intended to, and does not create any right, benefit, or trust responsibility, substantive or procedural, enforceable by law or equity, by either party, its officers, employees, or agents against the other party. Nothing in this MoU obligates either party to commit or transfer any funds, assets, or other resources in support of projects or activities between the two parties. Neither party will use the name of the other, either expressly or by implication, in any publicity, solicitation or advertisement without the express written approval of the other party to this MoU.



8. **COMPLIANCE WITH LAWS AND ABSENCE OF AGENCY:**

a. Both Parties shall comply with the relevant laws in the jurisdiction in which it is in situ and that all the visiting members from either of the institutions shall comply with all relevant laws in the jurisdiction of the host party.

b. That **NOTHING** in the MoU gives rise to a relationship of agency between the parties. **IN WITNESS** whereof both the parties have set and subscribe their respective hand and seals, and, this MoU has been duly executed on the date shown at the beginning of this MoU.


